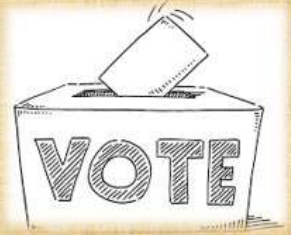

A session is delivered by **Hon'ble Swarnita Mahale, Additional Chief Judge, Small Causes Court, Mumbai, (The Cadre of District Judge)** on 'The Juvenile Justice (Care and Protection of Children) Act, 2015'.

The Programme was organized on online platform. It was commenced with the welcome speech and brief note about the theme by I/C Principal Dr. Sanjay K. Mandaokar.

The Hon'ble Speaker has discussed the importance of legislation on such important aspect. Further a brief note about **The Juvenile Justice (Care and Protection of Children) Act, 2015** is given. A webinar is conducted online on Google Meet platform for all NBT students jointly by Election Literacy Club, Legal Aid Clinic and District Legal Services Authority Nashik District Court, Nashik.


Dr. Sanjay Mandavkar, Incharge Principal of the college, said that students studying law need to understand the principle of voting rights and duties.

Gulve for legal aid through Nashik district legal services authority the main aim of this visit was to help the undertrial prisoner to file appeal in high court or to supreme court and it filed appeal then to gather information from them regarding it so that they can be made aware about the status of there case, Basically it is for such under trial prisoners who can't afford an advocate due to there poor financial condition then advocate is appointed on behalf of district legal service authority if they grant consent for it, As we know that advocate's profession is a noble profession and he must give preference to the needy & poor people of the society to get justice.

So accordingly Adv. gulve had given us three forms mainly Form 'A', Form 'B' and Form 'C' to collect the information about undertrial prisoners and make them aware about there right to get justice, So Form -A was for such undertrial prisoners who had already filed appeal, Form -B for them who don't want to file appeal and Form - C for those who wanted to file appeal.

Form - A I personally asked the undertrial prisoners firstly his name, His jail number as allotted, His sessions case number and filed in which sessions court, His appeal number and filed in which high court, His address, And contact number of any known person and lastly it is sign or thumb impression for consent.

Form - B Consisted only his consent for not filing appeal as most of the prisoners have completed the punishment during there undertrial duration only.

Form - C Was same as form A, I mainly dealt with undertrial prisoners who were charged U/S 302 of Indian penal code for murder and convicted in sessions court and some were undertrial in pocso case. Then one undertrial prisoner approached me as he wanted the copy of his 313 statement under criminal procedure code, So i took the necessary information from him like name of the sessions court, Name of the advocate who was appearing on his behalf sessions case number his problem was that he had already given advocate who not under district legal service authority but I assured him that will give your information to DLSA and try to get your copy of 313 statement as it can be given only to concerned advocate only. It was a good experience but sad part is that due to lack of finance the undertrial prisoners have to face the punishment in there undertrial only as they are having option to file appeal in high court but there financial condition unfortunately makes them to face hardship in the prison which as society is our failure that everyone don't get equal justice as I saw some cases like one undertrial prisoners who was convicted U/S 302 of IPC by sessions court had to face the imprisonment almost for 14 years without applying for bail in high court and another prisoner was facing undertrial for pocso who is even not convicted by special court still has to face imprisonment from some six and half years. Finally after collecting the information about undertrial prisoners we all students came out side from jail are and



then I submitted the information in Nashik district legal service authority office situated in Nashik District and sessions court premises.

CENTRAL JAIL- UNDER TRIAL PRISONERS SURVEY


On 11th May 2012 and 12th May 2012 We Visited Central Jail, Nashik Road under the Guidance of DLSA Nashik. To Main AIM of this Visit was to HELP the Under Trial Prisoners (UTP) to collect Information about their Cases, Trial, Advocates from them regarding it so that they can be made aware about the Status of their Cases. Basically it is for such Under Trial Prisoners who can't Afford an Advocate due to their poor financial condition then Advocate is appointed on behalf of DISTRICT LEGAL SERVICES AUTHORITY (DLSA) NASHIK. If they grant consent for it, As we know that Advocates Profession is a Double Profession and he must give Preference to the needy Society to get Justice.

So accordingly, DLSA Officer had given us a Sheet mainly in that sheet there are 1200+ Under Trial Prisoners Name, Code, Case Number, Case file year, about Advocate information, in all information fill in that sheet. So in that sheet I personally asked to the Under Trial Prisoners firstly their UTP Number, Later than they have Advocate or not, and if the Advocates are they Had so I asked your advocates are Private or from Legal Aid. And there are no any advocate then from DLSA Arrange Legal Aid Advocate to appoint for that Under Trial Prisoners.


In that form Firstly Prisoners Name, his Jail Number (UTP Number) his session case number, his family members name, mobile number, address, and lastly his sign or thumb impression for consent.

It was Good Experience but sad part is that due to lack of finance the Under Trial only as they are having option to file form but there financial condition unfortunately makes them to face to face hardship in the Prison which as a Society

is our failure that everyone don't get Equal Justice as a society some cases live one undertrial Prisoners who was convicted u/s 302 of IPC by sessions court had to face the Imprisonment almost for 14 years without applying for BAIL in High Court and another Prisoners was facing, undertrial POCSO who is even not convicted by Special court still has to face imprisonment from some six and half years. finally after collecting the information about UnderTrial Prisoners ,we all Students came outside from Jail and then I Submitted the Information in Nashik District Services Authority(DLSA) Office Nashik. Situated in Nashik District and Session Court Premises.
