VIDYALAYA, PANCHAVATI NASHIK**

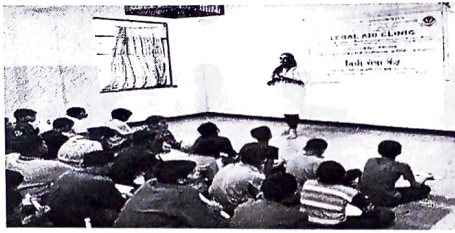
