



LEGAL AID VISIT REPORT

Introduction:

The legal aid is a Department in which the group of Legal practitioners, students and experienced lawyers are working which is supported and affiliated with DLSA i.e. District legal service authority. The objective of legal aid to provide free legal advice to the people especially for the economically weaker section of the society. The objective of legal aid department is to creating legal awareness within society. As we all are living in a civilized society which has a specific legal structure and everyone must follow it. As a law student it is our duty to creating such legal awareness, Educating and guiding the societal members for making them a law abiding citizens as well as helping the victims for getting them justice. With this objective our college i.e. N.B.T law college always took the active participation. The college encourages our law students to visit the various Govt offices, Industries, schools, colleges, senior citizens groups, and women clubs for creating legal awareness among them.

Objective of Visit:

The legal aid activity is a part of our curriculum of final year LLB students. The intention behind the this activity is to work closely with socio-legal problems, as the aspirant law students and would be legal practitioner it is most important to understand and identify the gap between law and its application at the every layer of society and trying to bridging it. The language of Law is complex to understand so that the layman remains unaware about his legal rights, in such scenario it is necessary that somebody from a legal background should create awareness among them.

With this objective of creating legal awareness, we students of LLB- III year have decided to visit a school for educating their students, as the school students are the upcoming generation and future of our country and it is important to build responsible and sensible citizens which further leads in a strong foundation of a good society. Following with the same aspect it is most important to educate the school students about their fundamental rights and their duties, there responsibility towards the environment and similarly educate them about the punishment for the same. It is also important to make them aware about the child abuse and its punishment etc..

With this regards our classmate **Mr. Sumant puranik** Coordinate with one of the famous school in Nashik and arranged the legal aid session on 16 th March 2023 organised the legal aid program in the Ravindranath Tagore School, kathe galli, Nashik for the students of 9 th class by taken the necessary approval from school and college authorities

Program Report:



The program started with the opening ceremony and welcoming the guest by school followed by the speech of **Mr. Manoj Pingale** sir, Director and Trustee of the school and **Mr. Sanjay Mandaokar**, Vice principal, NBT law college, Nashik. the Hon'ble speakers guided the school students about the legal aid program and its emerging need and benefits. After the formal introductory session, our college student taken an initiative to present their respective topics. The details of sessions are as follows:

1. Fundamental Rights:

Mrs. Rekha Patwardhan started the session with the basic introduction of the constitution and delivered her subject about the fundamental rights and duties of the every citizen's of India, in which she mentioned about the Article 14 to Article 30 and Article 32. It includes the Right to equality, right to freedom, Right against exploitation, Right to Education, Right to freedom of religion and Right to seek remedies. She further elaborated its importance and remedies if its get violated.

2. Child labour Act:

In developed India the ratio of school dropout students are still huge and the reason could be the inefficiency of parents to send the child to the school because of insufficiency of money. Most of the Childs we saw working near by the road side stalls, many children from poor economic background are engaged and working with the industries to provide financial support to their families. Any individual or organization absorbing or engaging child as labour is prohibited by passing the child labour act ..this scenario is describe by **Ankita Patil**, she further stated that if a child is working with his/her parents after school and in spare time, at their work place for the purpose of helping them it can not be said that it is a child labour.

3. Right to Education:

The subject of Ankita further takeover by **Pratiksha Vighe** and she elaborated that it is the fundamental right of a every kid to get education and should go to school. For such Government has taken up many steps to encourage parents for sending their kids to the school. By 86 th Amendment act Article 21A made right to primary education as a part of the right to freedom.

4. Anti-ragging Act:

Rujuta Mehendale stated that "When a student who have cleared his 10 th examination takes an admission in college for the further studies has to undergone or face ragging from the senior students of that particular college". The type or nature of ragging may be of bullying, tasks which leads physical or mental hurt and apprehension, sexual abuse etc... the nature of ragging may be in a minor to make fun out of it or serious in nature which may lead towards life hazard or abetting for attempting suicide are prohibited and punishable under the Anti-Ragging act.. the punishment for the same depending upon the effect of a ragging on victim, it may be in kind of imprisonment and fine or fine. Every



university, college must have the anti ragging committee to prohibit the ragging at college, mess, hostel, ground etc.. and if happened the necessary enquiry must be done by the committee and the wrongdoer may be punished by Detaining him from college/university, freezing the scholarship and awards, cancelling the admission etc.

5. **Sexual Abuse: (POCSO)**

A small kids are usually a soft target of an accuse, it may be the neighbor, close family friend, family member, stranger or a schoolmate, teacher, peon etc in most of the sexual abuse cases. **Mrs Suvarna Sathe** emphasis that It is most important to educate the kids about the good touch and bad touch and also about their body and private body parts where no one should touch them or compel them to do such with anyone else. The use of child in pornography, videos, movies or sexual harassment of a kid is unhuman and to prevent such the Prevention of child sexual offense Act was passed on 14 th Nov 2012. i.e. (POCSO act)

6. **Information Technology act:**

As we all seen a big transition period during last two years due to Covid pandemic and whole world including jobs, business and education switched to an online mode of communication i.e. mobile, computers etc..and all the kids get acquainted with online media, while using the online media students should be careful and conscious. Every coin has a two side likewise online media also has a good and bad sides. Now a days many cases of frauds, fake friendship request, misguiding are increasing. The consequences of information technology can not neglected but can be avoidable with due care and to prevent the crime rate, the information technology act was passed..... **Helal Sediqqi**

7. **Human Right Act:**

Every person has his rights as a Human Being and which can not be denied. Such basic rights are protected under constitution in fundamental rights and to prevent such the Human Rights Act . **Jaya Managate**

8. **Environment Act:**

Like human, we also need to take care of Mother earth by reducing the pollution. For betterment of life, the development is essential and which can not be possible without alteration or modification in natural resources. This alteration and modification leads towards the environmental harm. It is challenge to maintain environmental balance as well as the life betterment development, so as the court guideline the sustainable development is needed. **Nikita Nevkar** also highlited the case laws for the same and emphasis that to maintain the environmental balance we, people and students as a future generation should play important role for reducing pollution. With same intention various laws passes by central and state government i.e. environment protection act, water (prevention and control Act), Air (Prevention and control) act etc....



9. Motor vehicle act:

Manasi Aher highlighted the fact that now a days we saw many teenagers, adolescents are riding the vehicles and there parents are allowing them to do so, but it is not as per the law. If any offense or accident committed by him the procedure and punishment for the same will be applicable and proceedings will took place in juvenile court and parents are punished for it.

After delivering the various topics by the LLB III students and interaction with school students the legal aid session comes to its final stage i.e. closing. Our classmate **Mrs sayali pande** concluded the session by vote of thanks. Principal Mrs Pathak of Ravindranath English School felicitate Mr. Mandaokar and our team by giving bouquet as token of love.

Conclusion:

It was very encouraging experience to all of us and learning too. The legal aid activity give us an opportunity through which we could interact with the various layers of society and would able to understand the social problems. Through this session we all classmates worked in coordination with each other and have got opportunity to deliver our skill set in front of the school students.

CONDUCTED ON 20TH MARCH 2023
AT SHREE ACCOUNTANCY CLASSES, NASHIK

Every law school has to establish a legal aid clinic that is formally affiliated with the District Legal Services Authority at a District Court. The District Legal Service Authority offers the legal aid clinic support and direction. Orating skill is one of the main skills of a lawyer. A good lawyer is always a good orator.

- 2) Right to freedom (art 19-22)
- 3) Right against exploitation (art 23-24)
- 4) Right of freedom of religion (art 25-28)
- 5) Cultural and educational rights (art 29-30)

Constitution of India that prescribes fundamental obligation of states to its citizen



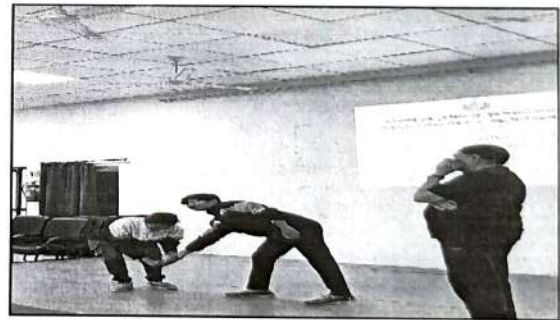
