# Stakeholders Feedback Report

N.B.Thakur Law College, Nasik affiliated to Savitribai Phule Pune University offers UG and PG courses like B.A LL.B, LL.B, LL.M and Diploma.1506 students are studying in the college in the academic session 2023-2024. The Internal Quality Assurance Cell (IQAC) of the college has been continuously working on improving the quality education and for betterment of students. This process is evaluated through circulation of feedback from amongst the students of the college. The feedback form is collected and the report focuses on the analysis of feedback form received from the students.

### **Data Collection and Analysis**

An effort was made to receive feedback from students who are studying in the college. For this purpose feedback form was created and circulated amongst the students. A total of 100 responses were received from student's community. The analysis of feedback form was performed using statistical tools like percentage, pie-chart and bar-graphs.

### Feedback on College

The feedback from was circulated amongst all the students from the UG and PG and Diploma courses of the college. 100 responses received, 76 % of students strongly feel that overall environment is conductive and good for learning and only 24% students were not happy about the overall college atmosphere. Majority 58 % of students strongly agree that there is adequate number of Classrooms in the College and Classrooms are well maintained and clean. This means that the college atmosphere is healthy and students enjoy coming to college and takes interest in learning. Students feel that standard of education of the college is very good.

#### Feedback on Teachers

An effort was made to access the student feedback on teachers of the college. For this, questions like teachers subject knowledge, their teaching method, their sincerity towards completion of syllabus and their behavior towards students were asked.

It was observed that 84 % of the students strongly agree that the teaching method adopted by the teachers is good. Maximum students believe that the faculty members in the college have good subject knowledge and they are cooperative and supportive. Out of 100 responses, 88% students responded that the teachers complete prescribed syllabus on time. Thus, the college provides well experienced faculties for the guidance and betterment of the students.

### Feedback on Library

The responses of the students regarding library facilities of the college were recorded and analyzed on the basis of feedback forms. It was found that 92 % students are satisfied with the library facilities provided in the college. More than 98 % students agreed that there is sufficient number of books available in the library according to their prescribed syllabus. While 26% students feel that there should be improvement in the facilities. Some students feel that there should be more number of copies of text /reference books and demanded prescribed / reference books in Marathi language. The students also agreed that the library staff is cooperative, prompt and helpful.

## Feedback on College Facilities

The student's response on facilities of the college like cleaning of washrooms, availability of drinking water, organizing of cultural events, educational tours and guest lectures and presence of sports facilities was recorded. The feedback forms were analyzed and it was found that more than 64% students were contended regarding the facilities provided by the college. It was observed that 55% of the students were satisfied with the sports facilities available in the college. The Institute assured the students that clean drinking water is available throughout the college and washrooms are always clean and maintained hygienically. Thus, the college offers safe and hygienic campus for the students. Students are happy with educational tours organized by the college. They believe that such events help in providing them help in enhancing their personality. Further, students also feel that expert lectures organized develop their practical as well as theoretical knowledge. The students feel that the office staff—of the college is helpful and supportive.
